Winning bidder is obliged to comply with the Provisions of Republic Act No. 6685 dated 12 December 1988 – An Act Requiring Private Contractors to whom National, Provincial, City and Municipal Public Works Projects Have Been Awarded Under Contract to Hire at Least Fifty Percent of the Unskilled and at Least Thirty Percent of Skilled Labor Requirements to be Taken From the Available Bonafide Residents in the Provinces, City or Municipality in which the Projects are to Undertaken and Penalizing Those Who Fail to Do So, that shall be Complied by the Contractor to whom the project will be awarded.
